Competition Rules:

1. **Points:** The match shall be determined by sets won; one point for every set won; in the event of an unfinished set the points shall be shared.
1.5 points to each team for a wet match.
2. **Format:** 2 Man Team; 3 Sets with Tie Breaker at 6 games all.
3. **Duration:** 7.45pm Start - 10.15pm Finish. The game in progress at 10.15pm is to be completed and if the set is unfinished the point for the set shall be shared.
4. **Start time:** Players are required to enter the court at 7.45pm, have a 5 Minute hit-up, and then commence the match. The first set must be commenced by 8.00pm otherwise the team having a pair ready to play may claim the first set.
5. **Substitution of Players:** A player can be substituted in all the rounds of the competition for any reason. A qualified player can only be substituted in finals to replace an injured player where the injury was sustained in the final.
However, if a player is substituted during a match, and as the competition is a two-man team format, only the last two players on the court in the 3rd set for the team that made the substitution can be considered as played the match and be considered eligible to play in the finals.

Please note that if a player is injured while playing a set and cannot continue, that set is forfeited. The substituted player can play the remaining set(s) were applicable.

6. **Eligibility for play in the Finals**

A player must have played three matches in the rounds to be eligible to play in the finals.

See requirements for Forfeits in item 7 below.

A minimum of one of the three matches has to be in the player's registered team. Each eligible player must have played at least two actual matches, i.e., a player registered for one played match and two forfeits or washouts is ineligible to play in the final.

Changes of Rules for the current Competition

(a) A semi-final player must have played three (3) matches in his team to be eligible to play in the finals (i.e., Semi and final.)

(b) An eligible replacement player who has not played in the semi-finals is eligible to play in the finals and this player shall be of a similar standard to the player that is unable to play.

Addendum: (10-02-2020)

The team requiring a substitute player for either Semi-Finals or Final must submit the name of the eligible substitute player to the THNM Competition Committee for ratification of his standard of play as with clause (b) above.

7. **Forfeits:**

In the event of a forfeit, the team receiving the forfeit shall be nominated on the Match Result Card for that match;(i.e., the two players that would have played are now accredited with playing in that forfeited match.). Providing that they have now played three matches in the rounds which includes the forfeited match. The team receiving the forfeit receives 3 competition points.

Key for 10 team formats: 1 & 6, 2 & 7, 3 & 10, 4 & 5, 8 & 9

8. **Determination of finalists:**

To determine the finalists the following criteria will be implemented:

1. Points accumulated in the round of the competition.
2. For teams on equal points – Count back: -Games Played versus Games won expressed as a percentage.
3. For teams still equal after Item 2. The Head-to-Head result between the teams in question.
4. For teams where either a draw or a washout on the head-to-head result, Games won results versus the team that came first apply.

9. **Location of the Finals:**

Location of the finals to be advised.

The Format: 1 V 4 and 2 V 3

10. **Prize Money:**

- Winning team to receive: \$200.00
- Runners up: \$80.00
- Team Registration \$60.00
